3. Proof of site acquisition (Attested Copy)  
**(Note: The CNG Station shall not be located in residential area)**
4. Financial Soundness certificate duly confirmed by reputable Bank regarding financial soundness as well as the ability of the applicant Firm to raise funds for the CNG project. (In Original)
5. Partnership deed in case of Partnership/AOP (Attested Copy)
6. Attested Copy (s) of N.I.C of the applicant (s)
7. Undertaking to the effect that the proposed CNG station is not being installed on a petrol pump or otherwise NOC from the concerned Oil Marketing Company (OMC) (In Original)

## **INSTRUCTIONS FOR FILLING THE LICENCE FORM**

1. Indicate the name of proposed CNG Station/applicant firm in para-1
2. Indicate whether the application is by Individual (Sole proprietor) or Individuals (Partnership) or a Company, in para-2.
3. Complete mailing address for correspondence with Phone No. in para-2 (a)
4. N/A should be mentioned in paras, which are not applicable.
5. Complete address of proposed site for the installation of CNG Station including Khasra, Khewat, Khatooni No., or Plot No. or Revenue Survey No. etc. as per proof of site acquisition documents in para-5.
6. Details regarding proposed CNG Station equipment and its allied facilities along with estimated costs in para-6.
7. The application form should be signed by applicant or Managing Partner in case of a Partnership concern or an authorized director in case of a Company.
